Impact of COVID-19 on migration in Serbia

Danica Šantić and Marija Antić, MIGREC team members, published a paper titled "Serbia in the time of COVID 19: between 'corona diplomacy', tough measures and migration management" in the scientific journal "Eurasian Geography and Economics".

The authors analyze the specificities of Serbia's response to coronavirus. Two most important issues during the pandemic were the role of the state and the management of migration flows. Serbia's placement in the China–Russia–EU triangle shaped its response on the crises but also the image of the country in the world. The "iron friendship" with China and traditional relations with Russia manifested themselves in immediate humanitarian aid. On the other hand, while the financial package from the EU was of significantly higher value, it failed to make a strong impression on public opinion.

Two phenomena shaped mobility patterns. Citizens returning from abroad were caught between accusations of spreading the virus and a plea for healthcare and other key workers from the Serbian diaspora to help in Serbia.

The issue of refugees and migrants attracted significant amounts of positive public attention, but in parallel with that xenophobia arose as a new attitude as a part of aggressive campaigns against them. How the country will cope with the large number of returnees and increasing number of refugees and migrants taking the Balkan Route in conditions of closed borders, economic downturn and prejudice and intolerance, remain extant dilemmas with no certain answer.
