# 1 RESEARCH @ SEERC

### 1.1 Research Projects Update

Three new externally funded projects were approved for funding and kick started in 2012. Another six projects were successfully completed.

#### 1.1.1 New Awards

**Broker@Cloud: Enabling Continuous Quality Assurance and Optimization in Future Enterprise Cloud Service Brokers.** The goal is to provide future cloud intermediaries with advanced means of monitoring both the obligations of each cloud service provider towards consumers (as well as towards the intermediary itself), and the opportunities for optimising the services each consumer receives.

**ISCOM:** Intelligent System in Supply Chain Monitoring and Optimization. The project aims to investigate, access and implement specialized methodologies and expert system technologies in order to support the production, supply chain and demand management of the highly sensitive products of food industry with a pilot to SMEs in the patisserie business.

**ICT-KOSEU:** supporting Dialogue and Cooperation between Europe and Kosovo (under UNSCR 1244) in Collaborative ICT R&D. ICT-KOSEU aims at supporting Kosovo's efforts for inclusion to the European Research Area by strengthening its capacity to participate to FP7 ICT research and by facilitating its ICT researchers' collaboration with researchers in the EU. The main elements of the project are: the implementation of a thorough ICT Technology Audit and an open consultation process that will lead to identification of the Kosovo ICT research priorities; facilitation of a dialogue between EU and Kosovo; and implementation of a capacity strengthening, networking and dissemination strategy that will provide assistance to local stakeholders in order to be able to participate on equal footing with their peers in the rest of the WBC and the EU to cooperative ICT research.
